Covid-19 Vaccination and Booster Requirement

Attention Silverado Associates working at a California Community or California Hospice Office.

As of December 22, 2021, California's Governor put into place a Covid-19 booster requirement for Health Care workers. This means that as of February 1, 2022, Silverado associates working in any of our California Communities or Hospice Sites must have completed a series of COVID-19 vaccinations including a booster (if eligible) in order to be in compliance with this new order.

Due to this new Order, Silverado has made an addition to our Covid-19 Vaccine Policy.

As you are aware, Silverado implemented a Mandatory COVID-19 Associate Vaccination Policy, which took effect March 1, 2021 for our Silverado Communities and as of August 9, 2021, this policy applied to all associates working at a Silverado California Hospice location. Consistent with the duty to provide and maintain a workplace free of recognized hazards, Silverado Senior Living Management, Inc. ("Company" or "Silverado") has adopted this policy to safeguard the health and well-being of Associates and their families, Residents, Patients, and others who spend time in our Memory Care Communities, and the community at large, from the risks associated with COVID-19. This policy is intended to comply with applicable federal, state and local guidance and authority, including guidance from the Centers for Disease Control and Prevention (CDC) and the public health and licensing authorities.

As of February 1, 2022,

1. Complete the full series of vaccine dose(s) based on the criteria outlined in the chart below:

COVID-19 Vaccine	Primary vaccination series	When to get the vaccine booster dose	Which vaccine booster dose to receive
Moderna or Pfizer- BioNTech	1st and 2nd doses	Booster dose 6 mos after 2nd dose	Any of the COVID-19 vaccines authorized in the United States may be used for the booster dose, but either Moderna or Pfizer- BioNTech are preferred.
Johnson and Johnson [J&J]/Janssen	1st dose	Booster dose 2 mos after 1st dose	Any of the COVID-19 vaccines authorized in the United States may be used for the booster dose, but either Moderna or Pfizer- BioNTech are preferred.
World Health Organization (WHO) emergency use listing COVID-19 vaccine	All recommended doses	Booster dose 6 mos after getting all recommended doses	Single booster dose of Pfizer-BioNTech COVID-19 vaccine

Or

2. Have obtained a written approved exemption as an accommodation for not receiving the vaccine and/or booster from the Home Office Human Resource department.
